Re: HB 3272 Filing Changes Data Call

General information

Oregon's Division of Financial Regulation (DFR) is seeking information regarding filing changes as a result of the passage of House Bill 3272 (2021). The division issued bulletin DFR 2021-5 on Nov. 8, 2021 to clarify the division's expectations for property and casualty insurers and provide guidance on expediting claims handling for Oregon policyholders affected by wildfires. At this time, DFR is not directing or requiring any specific communication with policyholders.

All insurers licensed in Oregon that are reporting direct premium written under the homeowners line of business on the 2020 annual financial statement are required to report. All companies required to report are listed in Appendix A of this letter.

Attached with this letter is the Excel reporting template required to be used to provide the requested information.

Please note: DFR will accept submissions that include multiple company responses. Each included company must have complete information in the reporting template. We will reject submissions with incomplete information or those not using the provided Excel reporting template.

All companies must submit completed Excel templates by end of day Monday, Dec. 6, 2021. Extension requests will not be granted.

All reports must be submitted using the provided Excel template via email to DFR.DataTeam@dcbs.oregon.gov.

Template fields to be reported

Submitted by information – Include the name, title, phone number, and email address for the person submitting this data call on behalf of the included company or companies.

Company name – Provide the full name for each included insurance company.

Company NAIC code – Provide the five-digit NAIC company code for each insurance company included.

Have you updated your company's filings to comply with HB 3272? (Yes or No) – If yes, provide the relevant SERFF tracking numbers. If no, provide a date by which you expect to have submitted the filing in SERFF.

Has the company communicated these changes with policyholders? (Yes or No) – If yes, select the methods of communication used from the following options: Updated filing endorsement at time of renewal, Written notice to policyholders, Both, and Other. If "Other" is selected, a brief description must be entered in the comment field provided in the Excel reporting template. If no, proceed to question 3.

Have the company's claims management personnel been directed to comply with the law in managing all claims? (Yes or No)

All information submitted in response to this request is confidential and will not be disclosed, except as provided in ORS 705.137. Failure to respond or delay in responding or incompletely responding to this letter by the end of the day Monday, Dec. 6, 2021, is in violation of ORS 731.296 and may be subject to enforcement action.
